Reason for Complaint/Details of Allegation:

Officer Robert Henry called CPS to make an emergency report. Police were called to Janet Morgan's home in response to a call from a neighbor. Two men were fighting in front of the home. The men had knives and were yelling at each other. The older two children were in the yard watching. Ms. Morgan is incoherent on the couch and is being arrested for possession of drug paraphernalia and a small amount of a substance believed to be heroin. Police have found several bottles of oxycodone with prescription labels belonging to others. Ms. Morgan is unable to give the name of someone who could care for the children, and police are requesting assistance. The oldest child provided the name of a family friend; however, police have not been able to reach this person.
