**Reason for Complaint/Details of Allegation:**

Hopewood Police Department called at 4:55 p.m. to report that Maria Diaz, 3-year-old sister of Javier, 15, called 911 at 4:25 p.m. to report that her uncle (and legal guardian), with whom she and her brother live, had hit her brother in the face with his fist. Her brother's eye was bleeding. Her aunt is there, but didn't try to protect her brother. Her uncle and brother are arguing and yelling at each other, and she's afraid things will only get worse. She was crying and very upset and asked that someone come right away.

Officer Gary Ridgefield was dispatched immediately and arrived at the residence a few minutes later. He found the 15-year-old boy injured as described, and the uncle, Mr. Gomez, admitted that he had hit his nephew, Javier, during an argument. Mr. Gomez said that Javier had disobeyed him. He (Mr. Gomez) told Javier he couldn't leave the house with his friends, and Javier tried to leave anyway. At that point, Mr. Gomez became very upset and hit Javier. Ms. Gomez was in the room during the incident, but did not try to protect her nephew from her husband. Javier seemed fearful of his uncle, and his sister Maria was afraid her uncle would hurt Javier again if police left. She stated she was not fearful for her own safety.

At this point, Officer Ridgefield called the Hotline to relay the incident and ask that the worker on call come to the home as quickly as possible. He said he would stay until the worker arrived.

The report was staffed with my supervisor, Nancy Walker, and was accepted for investigation and assigned as a Priority 1. It was passed on to the on-call worker, Kathleen Minor, and her supervisor, James Roberts, at 5:10 p.m. Ms. Minor was asked to respond to the home as quickly as possible.
