She explained that she got involved with her old group of friends, and everything got out of control. She was sober again and was attending NA groups that were offered at the correctional facility. She wanted to know if it was possible to have visitation with the girls. I explained that DCFS was considering filing for TPR and placing the children for adoption. Ms. Morgan said that she would fight it.
