Reason for Complaint/Details of Allegation:

Reporter, counselor at Jacksonville Elementary School, said that the Morgan family moved into this school district about 2 years ago. The reporter asserts that for about 4 months, Jessica, Layla, and Kerry have been coming to school unkempt and hungry and that the situation has increasingly become worse. The girls are now asking classmates for food at the cafeteria on a daily basis. Recently, Kerry Morgan told a friend that her mother uses drugs and sometimes leaves her alone with her sisters at night. The reporter also said that Layla Morgan was recommended for a developmental assessment several months ago and that the mother has not followed through. Layla suffers from a seizure disorder and does not take her medication reliably. Ms. Morgan has missed school conferences to discuss Layla's performance and behavior at school. The reporter said that the father no longer lives with the family, and she thought he might be incarcerated, but is not sure.
