Background Information

Janet Morgan came to the Live Again Substance Abuse Treatment Center (LASATC) on October 21, 2020, to participate in a substance abuse assessment and treatment, as indicated. She was referred to LASATC by the courts as a condition of probation following her arrest in July 2020 for possession. While participating in the program, Ms. Morgan informed the facility that her three children were in the custody of Mock State.

Social History

Ms. Morgan is a 30-year-old, petite, Caucasian female of average height and weight. She is the younger of two children in her family. Ms. Morgan's father died approximately 10 years ago. Ms. Morgan is estranged from her older sister and her mother and has not spoken with either of them in at least 5 years. Ms. Morgan reports that her family moved every 2 years as her father was in the military. Ms. Morgan said that her parents were not overly affectionate and ran a strict household, valuing independence and self-reliance. She reported that she often felt lonely. She denied a history of child abuse or domestic violence within the family. She said that neither of her parents used alcohol or other drugs. She said that she drank a few times in high school but had not experimented with other drugs.

Ms. Morgan met Raymond Capa in 2009. They had their first child in 2010 and a second child in 2012. The couple was never married. Ms. Morgan said that neither of their extended families approved of their relationship; however, her sister would assist with child care. Ms. Morgan reported that she was often the primary supporter of the family, saying that Mr. Capa abused alcohol on occasion and also was diagnosed as bipolar. At times, Ms. Morgan worked two jobs, one as a waitress full time and the other as a part-time cashier.

Ms. Morgan and Mr. Capa separated in 2013. Ms. Morgan said that she began seeing Justin Rogers a short time later. The two moved in together when she became pregnant with her third

child. Ms. Morgan said that her sister did not approve of Mr. Rogers and no longer assisted her with child care. Ms. Morgan reported that she quit working at that time to raise the children. In 2018, Mr. Rogers was arrested for drug possession and dealing and sentenced to serve 6 years. Ms. Morgan said she returned to waitressing and, through a combination of her earnings, tips, and the occasional child support she received from Mr. Capa, was successfully raising her children. In November 2018, Ms. Morgan said that while at work, she slipped in the restaurant's kitchen and injured her back. She was on workers' compensation for a number of months before being approved for disability. She was under the medical care of Dr. Cary Abernathy, and it was he who initially prescribed her opiates for pain management.

Ms. Morgan reported that Mr. Rogers' friends came to her assistance during this time and helped out with managing the children and household chores. She said that she was so desperate for assistance at the time that she overlooked the drugs and other issues that they brought into the family home. Ms. Morgan said that when Dr. Abernathy refused to increase her dosage to address her pain, it was these friends that introduced her to alternative street drugs. Ms. Morgan stated that she didn't realize how bad it had gotten until the police arrived at her home and her children were taken away.

Course of Treatment

At time of intake, LASATC supported Ms. Morgan with withdrawal symptoms, which included both pharmacological (buprenorphine) and psychotherapy. Withdrawal and detoxification were overseen by our staff physician. The goal was to safely ameliorate acute symptoms and support Ms. Morgan. Once Ms. Morgan completed withdrawal, a regimen of psychosocial and pharmacological therapies began.

Ms. Morgan participated in behavioral therapies as an essential part of her comprehensive treatment plan to prevent opioid use long term. These included contingency management and cognitive behavioral therapy. She created a plan for restructuring her life upon discharge to support her sobriety, which included developing a peer-support network and exploring opportunities for employment training programs, given her disability. Ms. Morgan also began addressing family and parenting issues, through during therapeutic visitations with her children. In addition to the mentoring and coaching that were provided during each visit, Ms. Morgan met with her counselor to debrief after each visit. Ms. Morgan has successfully completed treatment.

LASATC assisted Ms. Morgan with pain management. While at the facility, she began taking gabapentin, in combination with an exercise program, topical treatments, and acupuncture. The combination appears to have significantly reduced her pain and increased mobility.

Recommendations

1. Ms. Morgan continues with the cognitive behavioral therapy on an outpatient basis.

- 2. Ms. Morgan attends a self-help group (Narcotics Anonymous) daily upon discharge and reduces to three times a week after 1 month.
- 3. Ms. Morgan receives follow-up care and support for ongoing pain management.
